

**The Litter Genie Vet Office of the Month Sweepstakes
Official Rules**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. The Litter Genie Vet Office of the Month Sweepstakes (the "Promotion") begins at 12:00:01 PM Eastern Time ("ET") on February 1, 2020 and ends at 4:59:59 PM ET on September 30, 2020 (the "Promotion Period"). The Promotion contains a game of chance ("Sweepstakes"). The computer clock of the Sponsor (defined below) is the official time-keeping device in the Promotion.

1. **ELIGIBILITY:** The Promotion is open only to legal residents of the 50 United States (excluding Puerto Rico) and the District of Columbia, who are 18 (except Alabama and Nebraska 19 and 21 in Mississippi) years of age or older as of date of entry and certified veteranian or employee of an animal health provider. Employees, officers and directors of Rebel Gail Communications ("Sponsor"), Angel Care, Edgewell Personal Care, Realtime Media LLC ("Administrator") and their respective parent companies, affiliates, subsidiaries, advertising, contest, fulfillment and marketing agencies, (collectively, "Promotion Parties") their immediate families (parent, child, sibling & spouse and their respective spouses, regardless of where they reside) and persons living in the same households as such individuals (whether related or not) are not eligible to participate in the Promotion. Upon registering, you will receive one (1) entry into the Sweepstakes ("Sweepstakes Entry"). **Limit of one (1) Sweepstakes Entry per person, per email address throughout the Promotion Period.**

3. **SWEEPSTAKES DRAWING/ODDS:** The Sweepstakes will consist of eight (8) individual Monthly Drawings (each a "Monthly Drawing"). Each Monthly Entry Period will begin at a specified time (each a "Monthly Entry Period Start Time") and will end at a specified time (each a "Monthly Entry Period End Time") as detailed in the chart below and will be selected in an electronic, randomized drawing. The Monthly Drawing will be conducted on or around the monthly drawing date ("Monthly Drawing Date") specified in the chart below from among all eligible entries received during such Monthly Entry Period. Entries must be received before the end of the Monthly Entry Period to be eligible for the corresponding Monthly Drawing. All eligible non-winning entries from each Monthly Drawing will be rolled into the next Monthly Drawing.

4. **WINNER NOTIFICATION:** The potential prize winners will be notified by email and/or phone within three (3) business days of winner selection or as soon as reasonably practiceable. Potential winners will have ten (10) days to respond to winning notification before forfeiting their prize. ***CHARITY CRITERIA**

- Charity must be US-based and must be in operation for at least 1 year prior to the drawing date as a registered 501(c)3 organization.
- Charity must designate helping cats in need as part of its mission.
- Charity must agree that their name can be used by Litter Genie in press releases and on the Litter Genie website as a recipient of the donation that may include use of photographic images of the charity and/or its principals.
